Minutes for 2023 AGM approved without objection

Board Report Zsofia Mendly-Zambo:

- The Board has faced Interpersonal and communication challenges in the beginning of the 2023 / 2024 year.
- Board formed an ad hoc committee on Palestine and the Right to Food.
- Successfully delivered a student-focused Food Forum in Montreal despite planning challenges
- Expanded the board with new members, bringing additional energy and insight.
- The board will operate under a new non-hierarchical structure sharing the workload and responsibility
- The board was confronted with the aftermath of October 7th which led to the forming of the ad hoc committee Palestine working group now the weaponization of food in war.
- January 2024 the board was expanded with 12 new members.
- The ability to plan a full-scale conference with Congress was not attainable with a new board made up of primarily new people and the vast majority are graduate students and sessional lecturers. The decision to move to a student focused small symposium was supported by all board members.

Zhenhong became treasurer in January 2024. Last treasurer Danny kept records current until August 2023. An error in the spreadsheet was correct and the spreadsheet has been reconciled with the bank records.

Revenue as of May 1 2023 opening balance was \$32,879. with total revenue in the amount of \$23,842. A large proportion of the revenue is from the Federation, membership fees and revenue from the 2023 conference.

Expenditures for the same period are \$30,000 which highlights a deficit of \$7,000. Closing balance is \$25,769.

The Journal received fees from publishing and a total expenditure of \$2,9555 including administration, translation, copy editing and the cost to join Learned Journals.

Net expenditures over revenue resulted in a deficit of \$2,374.

There is approximately \$7,000 in the PaPal account to be transferred to the main bank account.

Jodi Koberinski noted that there may be outstanding invoices from the June 2024 conference in the amount of approximately \$2,000. or less.

<u>Michael Classens</u> to review accounts with the bank as there are charges for each E-transfer which should be waived due to the type of account the association has.

Rebecca Schiff had signing authority at the bank although she believes she resolved herself of that years ago as she has not been an active member for more than a decade. Rebecca has been to the branch in her community and removed herself from the account.

<u>Michael Classens</u> is to become the signing officer on the account by a unanimous vote of all members on the Zoom remote meeting call Thursday June 27, 2024.

The journal is open to suggestions about special issues or topics that the members would like to have published.


This the 10th anniversary with the first journal published in 2014.

There are three editor in chiefs and a core managing staff that are preparing the commentary for the next issue. There will be an overview - retrospective of where we have been, what we are doing and where we are going.

There have been 3 issues published each year. The current issue is Introducing Meat Studies. The organization of the journal, how it operates and and functions are noted in the graphic below.

David Santos was editor, co-editor in chief from June 2022 - MArch 2024 and has stepped down and Joanna Wilkes was the CAFS liaison and this role has been filled by Eric Chevrier.

CAFS now manages the budget for the journal which was previously held at Lakehead with a SSHRC grant which was extended to 2024 due to COVID.

SSHRC has suspended its aid to scholarly publication to revise open access policies. this will benefit CAFS as we are an open access journal.

The Canadian Association of Food Studies is committed to supporting the Journal with surplus funds when available.

Communications Report: Michelle Ryan

June 21, 2024 Statistics:

- Mastodon: 244 followers up from 241 in May 2024
- IG 731 accounts reached in the past 90 days, 281 accounts reached May 22nd
- LinkedIn 831 post views in the last 30 days . Post view 754 May 22nd
- Facebook, CFS posts reach 79 in the past month, 95 May 22nd
- Facebook, CAFS post reach was 278 in the past month, 214 May 22nd

Number of views increases after an issue of the journal is launched.

In June 2023 we switched from Google Analytics to G4 analytic software. We do not have 6 months of data due to the switch. An additional 5 weeks of data was missing and an average was used to calculate the number of readers per week.

The newsletter is no longer an attachment which makes it easier to send via listservs and easier to track readership.

Over the past years CAFS has been involved in activism: Ad hoc Committee on Palestine and the Right to Food and the support of the boycott deeply resonated on social media. This provides an opportunity to introduce food activism to people who might not necessarily be active themselves or might not see that as a venue for activism.

We track metrics specific to each article. Authors are asked to include their social media handles and those of their institutions to enable better tracking. Articles where the author included social media handles had 3 that made the top 50 pages for the month they were published

School Food Working Group Report. :Rachel Engler-Stringer

- The group is co-led by Amberly Ruetz and Racell Engler-Stringer
- There are 100+ members who are faculty, students and partner organizations.
- use Listserv for communication
- Contributed to Global School Meals Coalition report on Canada with Amberley Ruetz as lead
- National School food Program announced by the federal government in April.
- Policy released mid June, members will be asked to be involved in an associated research plan.
- There is a hope that the rollout is evidence based. The group is trying to put together a research framework around the rollout.
- There is great deal of work needed for the program. If there are interested parties they should contact Rachel Engler-Stringer

Ad hoc Committee on Palestine and the Right to Food Sarah Rotz

- The Canadian Association for Food Studies Ad Hoc Committee on Palestine and the Right to Food was established January 2024 with approximately 12 active members.
- Host two sessions to date
 - Panel on Food, Empire and Colonialism: From Palestine to Turtle Island
 - Film screening and discussion of the file "Aisha's Story"
- Currently developing an article out of the forest panel discussion for publication in the CAFS Journal.

Discussion : Conference planning with Care: Janelle Regneir - Davies, Julie Robertson, Jodi Koberinski

- Planning the 2024 conference was challenging and many of the people on the committee were new board members in January 2024.
- There was tension between the Federation and the conference Planning committee.
- There is a call for members to join the Planning committee for the 2025 conference.
- Congress is at George Brown in 2025. They have a new program and it is exciting to have them host. However, planning is strenuous with previous committee members spending more than 1,000 hours. This may not be attainable going forward.
- Options are to plan a conference at the same time as Congress but not aligned with Federation which could be less expensive but labour intensive
- CAFS could also host regional meetings across the country much like the Association of Geographer regional conferences with a full gathering every two or three years.
- These are conversations and decisions we need to make before the end of August to prepare for the following year.
- CAFS conferences are usually 2 to 3 days with panel discussion, and different sessions. There are times when we have been able to add tours of interest.


